If you are preparing a will for the first time, or making major changes to your will, please discuss your intentions to include Lewa Wildlife Conservancy with your lawyer. To make a change in your current will, your lawyer can prepare a codicil. A gift of a certain amount or a percentage of your estate can be designated to Lewa using the following sample language:
